

CENTREVILLE BANK STADIUM TAILGATING POLICY

APPLICABLE TO LOT M7

This policy is enforced in Lot M7, managed by Centreville Bank Stadium.

This lot is open to prepaid parking pass holders and event day parking lot users.

- Lot M7 typically opens two hours before the event unless schedule conflicts arise.
- One spot per vehicle per parking spot sold
- Ticket holders with multiple parking passes may use adjacent parking spaces for tailgating, provided they comply with the designated space regulations.
- Be courteous to others: tailgate only in your marked space and keep drive lanes clear. Blocking drive lanes is prohibited.
- All tables, chairs, coolers, grills and other equipment must remain within your designated parking spot. Tents or canopies larger than 8' x 8' and vehicles exceeding 16' in length and/or 8' in width are not permitted in lined parking spaces.
- Tailgating is allowed on the medians between the parking lots and roadways, but must not block pedestrian sidewalks.
- Saving parking spots is not allowed. Arrive with friends to tailgate near them.
- All cooking equipment must be placed at least 3' away from crowds, buildings, vehicles and combustible materials.
- Liquid charcoal starters or other flammable liquids are prohibited.
- Quick-starting charcoal is recommended.
- Open flames are allowed, but all unattended barbecue equipment must be extinguished.
- Ash containers, trash containers and portable restrooms are located in the lot.
- Hot ashes, cinders, smoldering coals, disposable LP-gas cylinders and other hot materials must be disposed of in designated dumpsters.
- All trash must be disposed of in the designated receptacles.
- Glass containers are prohibited.
- Centreville Bank Stadium and Rhode Island FC prohibit advertising, banners, signs or promotional items on the property. Tailgaters may be asked to remove any inappropriate materials. Guerilla marketing is strictly prohibited, and no sales of any kind are allowed in the parking lot.
- Music speakers must be kept at reasonable levels as determined solely by Centreville Bank Stadium management and/or in accordance with applicable City of Pawtucket ordinances.
- Open containers of alcoholic beverages are only permitted within Lot M7. Possession of alcohol on public property, including streets or sidewalks, may result in fines and/or arrest by law enforcement.
- For safety, all tents, chairs and other equipment must be stowed before entering Centreville Bank Stadium.

- Tailgating is usually allowed for up to one hour after the event. Guests may need to clear the lot earlier if schedules require.
- Tailgating ends 30 minutes before an event and may continue up to one hour afterward. For events starting at 6 p.m. ET or later, post-event tailgating is not allowed.
- Drink responsibly—guests who appear impaired may not be allowed into Centreville Bank Stadium.
- **Centreville Bank Stadium and/or Rhode Island FC reserve the right to revoke a parking pass at any time for failure to follow these guidelines.**
- **Lot M7 is private property, and permission for tailgating can be revoked at the owner's discretion. Please be respectful of Centreville Bank Stadium's neighbors.**
